### State Required Contamination Monitoring of Recyclables

California state law SB 1383 requires jurisdictions to monitor trash, recycling, and organics barrels to minimize contamination. Trash and other contaminants in the recycling or organics collection container(s) could result in a fee and non-collection due to contamination. If contamination is found, contamination tags (as shown to the right) will be affixed to the container lid. After the first notice, customers may be charged a contamination fee and the container will not be serviced as recyclable; it will be subsequently serviced as trash. Please note: the contamination fee will be automatically assessed if hazardous or bio-hazardous materials are placed in any collection container. Not sure about what goes in each container? ### Bulky Item Pick-Up

Are you replacing an old sofa, water heater or refrigerator and don't know what to do with it? We'll take care of it! Residents on trash barrel service can request up to four (4) curbside collections of large or bulky items during a 12 month period. Limit of five (5) items per collection. This program also includes electronic waste. This program is at no additional charge and designed for your convenience. Please call Burrtec's Customer Service Department to arrange pick-up on your next scheduled collection day. Additional pick-ups are available for a fee.



### Extra Holiday Waste

Approximately 80% of your holiday trash is recyclable. All gift boxes, wrapping paper, greeting cards, and cardboard packaging are items that may be placed in your recycling barrel. Burrtec will collect your excess holiday trash and recyclables. Beginning the day after Christmas for approximately 1 week, place excess holiday trash/recyclables in bags alongside your containers on your collection day.

### The Holidays Are Soon Approaching!

Burrtec will collect and recycle Christmas trees from single-family residences. Please place your tree at curbside after Christmas on your collection day. Burrtec will provide this service for approximately a 2 week period after Christmas Day. Trees 6 feet and over need to be cut in half. Please take all ornaments, lights, and metal stands off of the tree. Flocked trees will not be recycled, they will be collected as trash. Flocked trees 6 feet and over also need to be cut in half.



### Holiday Schedule - No service on these holidays



Memorial Day		Independence Day		Labor Day

When the holiday falls on a weekday, collections for the remainder of the week will be delayed by one day. There is no service interruption or delay when the holiday falls on a Saturday or Sunday.



# Household Hazardous Waste

San Bernardino County collection facilities accept a wide variety of household generated hazardous wastes. These services are FREE for San Bernardino County and City of Montclair **residents only**.

- Pesticides & Fertilizers, Pool & Hobby Supplies
- Auto & Household Batteries
- Motor Oil, Oil Filters
- Electronic Waste Collection available throughout San Bernardino County.

- Outdated Medications

## Collection Facilities

### Will Not Accept:

- Business Wastes
- Wastes from Non-Profit Organizations
- Radioactives
- Explosives
- Medical Waste
- Asbestos

Before transporting household generated hazardous waste to a collection facility be sure...

- ✓ The amount of waste transported does not exceed 15 gallons or 125 pounds. Container volume must not exceed 5 gallons.
- ✓ The containers are sound, not leaking and sealed.
- ✓ The waste is in its original container or is properly labeled as to its contents.
- ✓ Waste is placed securely in the vehicle for safe transport.
- ✓ The contents of the container are the same as stated on the label. If not the same, cover up the label and write the name of its contents.
- ✓ To place items in a cardboard box. Wrap glass bottles in cloth or newspaper so they do not break while transported.
- ✓ To place the cardboard box in the trunk of your car or in the bed of your pickup truck. Keep items away from passengers.
- ✓ To follow directions once you reach the collection site.
- ✓ That at the site, staff will unload the chemicals from your vehicle. You will be asked to stay inside your vehicle.
