#### Winter Weather

Winter weather conditions, such as icy roads, heavy snow, excessive mud, or flooding conditions, may present delays with your regularly scheduled waste collection route. We are committed to the safety and protection of our employees and the community. Collection service could be impacted due to: low visibility, icy roads, impassable and/or unplowed roads/alleys.

Please be aware that while your street may be clear, access to your neighborhood may not. We will attempt to service on your regularly scheduled collection day anytime between 6 am to 6 pm. If we are unable to service due to the winter weather/road conditions, please bag any excess trash and recyclables that will not fit in your container(s) and Burrtec will collect all accumulated bags on the next service day.

Bundles of wood/branches can be no more than 4ft long and 2ft diameter.

All sites require your most current trash bill for proof of service.

#### Service Fee Waiver Program

Residential Solid Waste Collection Service is Mandatory in designated unincorporated areas of San Bernardino County. Customers whose homes are vacant or have infrequent use may apply for a Fee Waiver. Fee Waivers are granted one time per year for qualified months in the prior year where a household is at or below a six (6.00) Kilowatt Hour (KwH) daily average of electrical use for any given month requested.

- Fee Waiver Applications must be received no earlier than January 1st and no later than February 28th of the year following the prior year's credit or refund request.
- To qualify, accounts must have a zero balance as of December 31, 2025.

#### Extra Holiday Waste

Approximately 80% of your holiday trash is recyclable. All gift boxes, wrapping paper, greeting cards, and cardboard packaging are items that may be placed in your recycling barrel. Burrtec will collect your excess holiday trash and recyclables. Beginning the day after Christmas for approximately 1 week, place excess holiday trash/recyclables in bags alongside your containers on your collection day.

#### The Holidays are Soon Approaching

Burrtec will collect and recycle your Christmas tree! Residents with curbside collection, please place your tree at curbside after Christmas on your regular collection day. Trees 6' and over need to be cut in half. Please take all ornaments, lights, and metal stands off of the tree. Burrtec will provide this service for approximately 3 weeks after Christmas Day. If you have Clean Mountain service, please bring your tree to any one of our six drop off locations (see map on page 2). 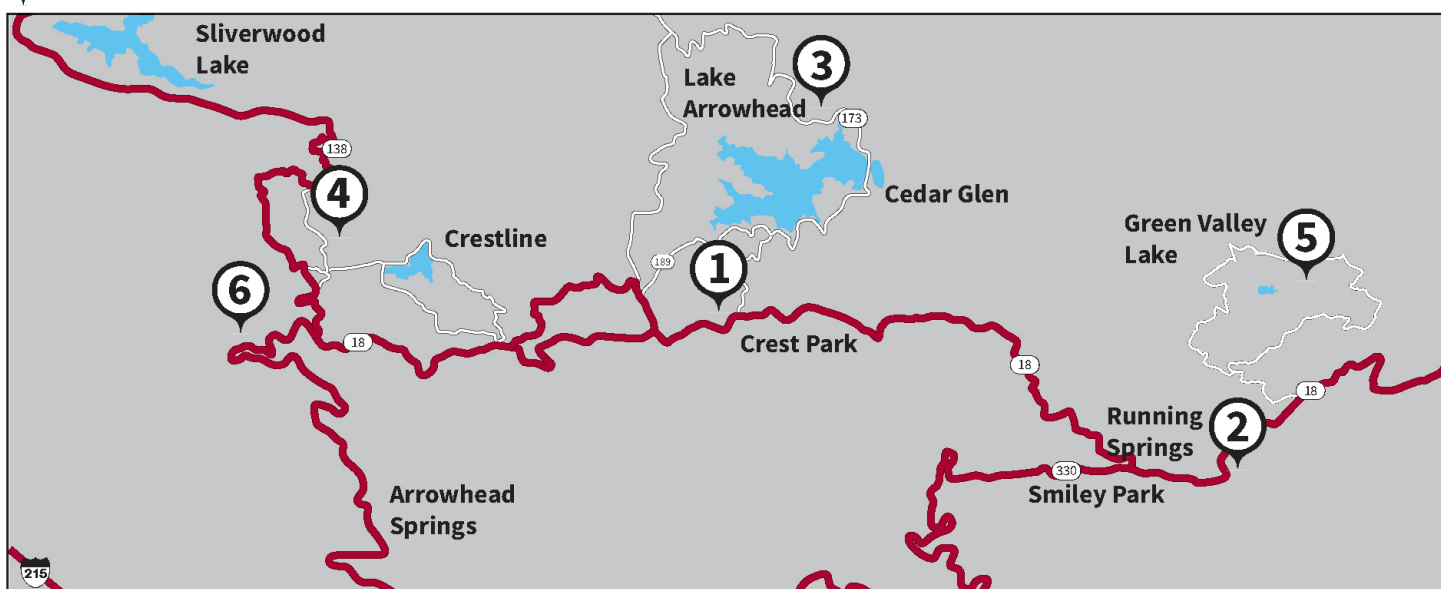
# CLEAN MOUNTAIN SITES DROP-OFF LOCATIONS FOR TRASH, RECYCLABLES AND GREEN WASTE

**ALL SITES REQUIRE YOUR MOST CURRENT TRASH BILL FOR PROOF OF SERVICE**

The Burrtec Clean Mountain Sites are for residential properties subscribed to curbside or clean mountain service. The sites are open every weekend with the exception of Burrtec recognized holidays and Easter Sunday. For more information, contact Mountain Disposal at (909) 338-2417, Monday through Friday, 8:00 AM to 5:00 PM.

**Clean Mountain Sites may close during periods of inclement weather or if unsafe/hazardous conditions exist for the public and staff.**

## CLEAN MOUNTAIN SITES OPERATING GUIDELINES

- All residential household trash brought to the site must be in a 32-gallon trash container. Limit of 5 cans per property, per day.
- Green waste must be in a 32-gallon trash container or bagged.
- Tree branches and limbs brought to the site cannot exceed 4-feet in length and must be tied in bundles no bigger than 2-feet in diameter.
- Unlimited green waste is accepted, per single family generator, as long as it's contained.
- You may bring **two** bulky items per day; this includes E-Waste.
- Renters and vacationers are required to bring a copy of a current invoice. Please reach out to the property owner or management team for more information.
- **No trailer loads or loose materials will be taken. These items can be hauled off to Heaps Peak Transfer Station located at 29898 State Highway 18, Running Springs, CA 92382.**
- **Household Hazardous Waste (HHW) is not accepted. HHW consists of items such as paint, motor oil, paint thinner, turpentine, pesticides and herbicides. For information regarding the disposal of HHW, call 1-800-OILY CAT**
- **No construction material or tires are accepted at any of the sites.**
- **Landscapers and third-party haulers are NOT allowed to use the drop off locations for any material types.**
