Sustainability Update

The 2022 FOOD WASTE Recycling Program and YOU!

The California Senate passed a bill to **improve air quality and reduce greenhouse gas emissions. CalRecycle** reports that landfilled organic waste (including green waste and food waste) decomposes in landfills and generates greenhouse gases contributing to global climate change. Starting in 2022, all California residents may be required to participate in a Food Waste Recycling Program in order to comply with **Senate Bill 1383**.

Senate Bill 1383 requires a 75% reduction in organic waste disposal statewide by 2025.



All residences and commercial businesses may be required to participate in this program to **recycle organic waste, including green waste and food waste.**

Bulky Item Pick-Up

Are you replacing an old sofa, water heater or refrigerator and don't know what to do with it? We'll take care of it. Residents can request up to two curbside collections of large or bulky items during a calendar year. Limit of five items per collection. This program also includes electronic waste. This program is **FREE** to curbside service customers and designed for your convenience. Please call our Customer Service Department one week prior to your scheduled collection day to arrange pick-up. This collection does not include concrete, rock, dirt or construction/demolition materials, hazardous waste (paint, oil, etc.), or tires.

Memorial Day Thanksgiving Day Independence Day Christmas Day Labor Day New Year's Day


When the holiday falls on a weekday, collections for the remainder of the week will be delayed by one day. There is no service interruption or delay when the holiday falls on a Saturday or Sunday.

Clean Mountain Sites Drop-Off Locations for Trash and Recyclables

All sites require your most current trash bill for proof of service.

The Burrtec Clean Mountain Sites are for residential properties subscribed to curbside or clean mountain service. The sites are open every weekend with the exception of Burrtec recognized holidays and Easter Sunday. For more information, contact Mountain Disposal at (909) 338-2417, Monday through Friday, 8:00 AM to 5:00 PM.

Clean Mountain Sites may close during periods of inclement weather or if unsafe/hazardous conditions exist for the public and staff.



Clean Mountain Sites Operating Guidelines

- All residential household trash brought to the site must be in a 32-gallon trash container. Limit of 5 cans per property, per day.
- Green waste must be in a 32-gallon trash container or bagged.
- Tree branches and limbs brought to the site cannot exceed 4-feet in length and must be tied in bundles no bigger than 2-feet in diameter.
- One truck level full (approximately 10-12 bags) of pine needles per day is accepted as long as it's contained.
- You may bring **two** bulky items per day; this includes E-Waste.
- No trailer loads or loose materials will be taken. These items can be hauled off to Heaps Peak Transfer Station located at 28638 Rim of the World Hwy. Running Springs, CA 92382.
- Household Hazardous Waste (HHW) is not accepted. HHW consists of items such as paint, motor oil, paint thinner, turpentine, pesticides and herbicides. For information regarding the disposal of HHW, call 1-800-OILY CAT
- No construction material or tires are accepted at any of the sites.
