

MANDATORY ORGANICS LEGISLATION

California passed a law, Senate Bill 1383, with a goal to improve air quality by reducing negative emissions from food waste and landscape waste being delivered to landfills. This law requires businesses and multi-family complexes to recycle their food waste and landscape waste. It also requires edible food generating businesses such as grocery stores, food service distributors, supermarkets and restaurants to provide the edible food (that would otherwise be disposed of) to organizations that will redistribute it. The State requires that applicable business generators:

- Separate organic waste from other waste and participate in a waste recycling service that includes collection and recycling of organic waste, or:
- Recycle its organic waste on site, or self-haul its organic waste off-site for recycling, or:
- Donate edible food waste to an eligible food rescue organization.

Please note: businesses should check with the City of Rancho Cucamonga for self-haul and on site recycling requirements.

MANDATORY SOLID WASTE SERVICE & PAYMENT

Solid waste collection service and payment for solid waste collection service is mandatory for every occupied residential, commercial and industrial property per the Rancho Cucamonga Municipal Code. Solid waste collection fees that are 60 or more days past due shall constitute a lien against the property for which the solid waste collection services were provided and shall include the delinquent amount plus administrative fees.

TRASH SERVICE

Burrtec provides waste collection services, to all of the commercial and industrial establishments in Rancho Cucamonga. If you would like to review your business's waste and recycling programs, please contact our office at (909) 987-3717 to receive a free waste assessment.

Bin Services

Sizes ranging from 1.5 cubic yards to 6 cubic yards
Compactor bins in 3 to 4 cubic yards

Roll-off Services

10 Cubic yard demolition or roofing boxes
20, 30, and 40 cubic yard debris boxes
40 cubic yard compactors

Temporary Bins

3 cubic yards for special clean-up projects

Special Services

Locking bins (trash or recycling)
Extra pick-ups



LARGE OR BULKY ITEMS

Burrtec will collect unwanted bulky items at your business or multifamily complex at no additional charge. Please place items in the designated area or next to the bin or bin enclosure. Large or bulky items include: illegal dumping, scrap metal, wood, old appliances, furniture, televisions, computer monitors, refrigerators, tied & bundled tree branches, mattresses, etc. Multifamily complexes will be serviced once a week, no call is necessary. Commercial customers can call in and request a bulky item pickup. Please place items out the night before or no later than 6:00 a.m. on the day of collection.



ORGANICS RECYCLING

Recycling of organics, such as landscape waste and food waste, is mandatory for businesses in accordance with California Senate Bill 1383 (SB 1383). Landscape waste and food waste must be handled and stored separately from trash and other recyclables to avoid contamination. All businesses are required to separate food waste and green waste from trash and other recyclables. All multifamily complexes are required to recycle food waste and green waste in the organics barrel.

Landscape Waste

Landscape waste/green waste services are available to all commercial customers in the City of Rancho Cucamonga.

MANDATED RECYCLING

One outstanding feature of Burrtec's commitment to the City of Rancho Cucamonga is recycling collection at no additional charge. Our recycling team is eager to help implement successful recycling programs that are customized to suit the needs of your business. A specialist will visit your business to gain an understanding of operations and to identify any items for recycling. After the site visit, a program is designed to help reduce costs and increase recycling.

California Assembly Bill 341 (AB 341) includes a mandatory commercial recycling component in the effort to save landfill space. All businesses with four or more yards of collection service (per week) will be required to establish and maintain recycling service.

DO NOT mix trash or hazardous waste with recyclable materials. Contaminated materials can often prevent recyclables from being reclaimed. Please recycle responsibly.
